On 10.06.2026 at 16:00 hours, a CD file was received from Kukatpally Police Station, Cyberabad, in Cr.No. 662/2026 U/S 316(2), 318(4), 351(2) BNS, on the instructions of the Commissioner of Police, Cyberabad, vide Memo No.77/C2/CD-File/Cyb/2026, dated 08.06.2026, through DCP CRIMES and EOW, Cyberabad. Brief facts of the case are that the petitioner Sri. Naidu Hanamantharao, S/o N. Venkatanarayana, aged about 62 years, Occupation: Business from Plot No-142, Shop No-2, First Floom, Balaji Commercial Complex, Bhagya Nagar colony, Kukatpally, Hyderabad # 9100991818. in which he stated that The genesis of the transaction is not a mere money lending dispute. The accused i.e., (i) Mr. Gudluri Ashok Babu, (ii) Mrs. Gudluri Vijayalaxmi and (iii) M/s A4 Motion Pictures, were introduced through one Mr. Nayeem, who represented that they were producing a film and searching for a male lead. The accused approached the complainant and his family, narrated the story and promised to launch his son as the hero, assuring fame, publicity and career opportunities in the film industry. They further represented that the project was commercially viable, involved a budget of about Rs.8 crores, and assured repayment with profits within six months, thereby inducing the complainant to invest money. Believing their representations, the complainant transferred amounts through banking channels on various occasions between 03.09.2024 and 02.12.2025, totalling Rs.3,05,00,000/-. Apart from this, the accused also collected one cheque for Rs.45,00,000/- which remains unclaimed. However, except for a nominal commencement of shooting in December 2024, the accused failed to complete the film project and diverted their attention to other works, thereby dishonestly retaining the complainant's money. Upon repeated demands, the accused executed a Deed of Acknowledgement dated 24.01.2026 at Kukatpally, Hyderabad, admitting liability and agreeing to repay about Rs.4.50 crores. They issued promissory notes and cheques bearing Nos.135492 to 135496, each for Rs.50,00,000/-drawn on SBI, Ongole Branch. Despite repeated notices dated 17.03.2026, 30.03.2026 and 07.04.2026, the accused neither repaid the amount nor provided any bona fide explanation. The cheques were dishonoured on 16.04.2026 With the endorsement "Cheque data is not pre uploaded," despite prior intimation regarding Positive Pay compliance, showing deliberate intention to evade repayment. Further, when repayment was demanded, the accused criminally intimidated the complainant and his family with threats of ruining his son's future, refusing payment, threatening false complaints and warning against approaching the police. Thus, the acts of the accused clearly disclose cheating, criminal breach of trust, dishonest inducement, deliberate dishonour of cheques and criminal intimidation. Hence, the complainant requested necessary legal action against Mr. Gudluri Ashok Babu, Mrs. Gudluri Vijayalaxmi and M/s A4 Motion Pictures in accordance with law, Hence the FIR Received On 10.06.2026 at 16:00 hours As per the contents of the CD file and as per the endorsement of DCP CRIMES and EOW, Cyberabad I, J.Venkateswarlu Inspector of Police/ SHO EOW PS, Cyberabad, re-registered a case in Crime No: 63/2026, U/s. 316(2), 318(4), 351(2) BNS and the CD file handed over to Sri. Through the reference 2nd cited, the SHO Kukatpally has requested to transfer the CD file in Cr.No.662/2026 U/Sec. 316(2) 318 (4) 351(2) of BNS PS of Kukatpally of Cyberabad to PS EOW of Cyberabad for further investigation the same was forwarded by the ACP Balanagar Division and DCP Kukatpally Zone, Cyberabad.

During the course of the investigation, IO has examined and recorded the Statement of De-facto complainant/LW1/Naidu Hanamanthrao and collected Xerox copies of relevant documents.

As per the version of the complainant dated 08.05.2026 the alleged accused approached the complainant and his family. members, narrated a film story and promised to launch his son as hero in the film. Believing the version of the alleged accused the complainant transfer an amount of Rs. 4.5 crores through Bank on various occasions. The alleged accused failed to complete the film project and dishonorly retained the money of the complainant and refused to returned the amount to the victim.

It is alleged that, after receiving the said amounts, the accused failed to complete the proposed film project and did not refund the money despite repeated demands. The allegations prima facie disclose elements of a financial fraud involving a substantial amount.

The statement of witnesses and investigation it is disclosing that the accused cheated the Victims fraudulently. The IO opined that the amount involved in this case is nearly Rs.4.5 Crores.

As per the Memorandum C.No.243/CCRB/Cyb/2024 Dt. -04-2024 where the cases registered under the Financial Fraud, including Frauds where there is fabrication of documents where the value of the fraudulent amount or property is more than 3 crore the case has to be transferred to PS EOW for further investigation.

Therefore, the entire original CD file in Cr.No.662/2026 U/Sec. 316(2) 318 (4) 351(2) of BNS PS of Kukatpally of Cyberabad is transferred to EOW PS Cyberabad for further investigation and instructed to re-register the above case and intimate the cross-crime number to SHO Kukatpally under intimation to this office without fail.

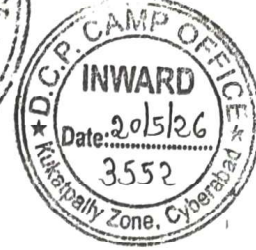

As per the contents of the above complaint, I have registered a case in Crime No. 662/2026 U/s: 316 (2), 318 (4), 351(2) BNS and took up the investigation.

During the course of investigation, I have examined the complainant and recorded his detailed statement which is incorporated in part-II CD, in his statement he corroborated the contents of FIR facts, further I have issued a notice U/s 94/179 BNSS to the complainant to produce the relevant evidence related to this case and witnesses to prove the prima facie against the above accused persons, on which he assured that he will provide the evidence within 2-3 days. After getting the evidence then will proceed further investigation into this case.

Further complainant submitted relevant documents related to this case. On verifying the said documents provided by the complaint, it came to light that the complainant was cheated by the accused which is more than 4.5 crores.

Earlier a Memo vide 2nd reference has been issued with instructions to transfer the case in the following condition which are as follows.

- The cases which are registered at the jurisdiction of Police Station which are eligible to be investigated at EOW.
- Financial Frauds including frauds where there is forged and fabrication of Documents where the value of the fraudulent amount or property is more than Rs. 3 Crores.
- Basing on the statement of the complainant and as per documents, the accused person cheated the complainant which is more than 4.5 crores.

On which it is to submit the above Conditions was applicable to this case as the case pertaining to the offence cheating with intentionally with an amount or property is more than 4.5 Crores.

The offence committed by the accused persons are involved in huge amounts collected/transferred fraudulently in deceitful manner from the complainant. As such the case needs to be exclusively investigated by Economic offences wing.

Hence, it is requesting to accord permission to transfer the CD file to EOW for further investigation.

Venkatanarayana, aged about 62 years Occupation: Business, carrying on business from Plot No.142, Shop No.2, First Floor, Balaji Commercial Complex, Bhagyanagar Colony, Kukatpally, Hyderabad - 500072, submit this complaint seeking immediate criminal action against (i) Mr. Gudluri Ashok Babu, (ii) Mrs. Gudluri Vijayalaxmi and (iii) M/s A4 Motion Pictures operating from H.No.3-7-389/89, Sri Bhavani Nivas, Nalandanagar Walkers Park Upperpally, Attapur, Rangareddy, Hyderabad - 500030, PAN No. ABSFA6172E.

The genesis of the transaction is not a mere money lending dispute. The accused were introduced to us through one Mr. Nayeem, who represented that the accused were connected with a proposed film project and were searching for a suitable boy/male lead/hero. Pursuant thereto, the accused approached me and my family, narrated the film story, represented that my son would be launched as the hero/male lead, and assured that the project would give him publicity, fame and career advancement in the film industry.

The accused further represented that the proposed film would be commercially viable, that the project could involve an overall outlay of about Rs.8 crores, that returns could be substantial, and that our financial contribution would be returned within about six months. They also represented that additional financiers, subsidies/foreign funding and other arrangements would be secured, and that we would receive a decent return/profit over the financed amount. These representations were made repeatedly, with the clear intention of creating confidence and inducing us to part with monies. Believing the aforesaid representations, we transferred monies through banking channels from time to time. The complainant, believing the representations and assurances of the accused persons, transferred substantial amounts through banking channels from time to time. In particular, a sum of Rs.25,00,000/- was transferred on 03.09.2024, a sum of Rs.50,00,000/- was transferred on 01.10.2024, a sum of Rs.70,00,000/- was transferred on 19.11.2024, a sum of Rs.25,00,000/- was transferred on 19.12.2024, a sum of Rs.20,00,000/- was transferred on 28.01.2025, a further sum of Rs.20,00,000/- was transferred on 15.07.2025, and a sum of Rs.95,00,000/- was transferred on 02.12.2025. Thus, the accused persons received, through account transfers alone, an aggregate sum of Rs.3,05,00,000/- from the complainant. Apart from the above account transfers aggregating to Rs.3,05,00,000/-, the accused also obtained/collected one cheque for Rs.45,00,000/-, which has not yet been deposited/claimed. Despite receipt of such amounts, the accused did not undertake and complete the film as promised. Except for a nominal commencement of shooting around December 2024, the project was thereafter virtually abandoned and the remaining shooting was not completed. We also learnt that the accused were proceeding with other film works/other persons while the project for which we were induced to pay was left unattended. This clearly shows dishonest inducement, diversion of purpose and wrongful retention of money. When we demanded either completion of the film or return of money, the accused repeatedly stated that they would repay within six months, that financiers would be arranged, and that payment would be made shortly. When the accused could no longer deny the transaction, they executed a written Deed/Agreement dated 24.01.2026 at Kukatpally, Hyderabad, titled "Deed of Absolute, Irrevocable and Unconditional Acknowledgment of Debt, Personal Guarantee, Interest Undertaking and Cheques and Promissory Notes Repayment Obligation". Under the said document, the accused admitted the liability of approximately Rs.4,50,00,000/- towards the acknowledged principal repayment obligation and agreed interest/return component. In particular, cheque nos 135492 to 135496, each for Rs.50,00,000/-, all dated 31.03.2026 and drawn on State Bank of India, Kurnool Road Branch, Ongole, were issued in my favour. WhatsApp/ email/post. However, the accused neither paid nor gave any bona fide explanation. Upon re-presentation, the above cheques were again dishonoured vide return memos dated 16.04.2026 for the reason 'Cheque data is not preuploaded'. The accused had already been informed to comply with Positive Pay requirements; therefore, this omission was deliberate and intended to defeat encashment.

During demands for repayment, the accused adopted a threatening posture and, inter alia, stated in Telugu 'మీ అబ్బాయికి పూర్వదర్ లేకుండా చేస్తాం' (we will ensure that your son has no future); 'రూపాయి ఇవ్వను, ఏం కావాలంటే అది చేసుకో' (I will not pay even a rupee; do whatever you want); 'మీ ప్యామిలీని ఏం చేయాలో అది చేస్తా' (I will do whatever I want to your family); 'సినీమా చేయను, మీ మూలంగా సినీమా అవ్వలేదు' (I will not do the film, because of you the film did not happen); 'పోలీసుల దగ్గరకి వెళ్తే నీ సంగతి చూస్తా' (if you go to police, I will deal with you). Mrs Gudluri Vijayalaxmi also threatened to foist false complaints against me, my family and my son and to approach Film Chamber/other authorities with false allegations. These threats were intended to intimidate us and prevent lawful recovery.

The above facts disclose a clear criminal design: introduction through a film opportunity, false promise to launch my son, staged collection of huge monies, non-completion of the film, execution of agreement/promissory notes/cheques admitting about **Rs.4.50** crores, deliberate dishonour/evasion and threats. The acts prima facie attract offences including cheating, criminal breach of trust, criminal intimidation, criminal conspiracy and allied offences under the Bharatiya Nyaya Sanhita, 2023, apart from proceedings under the Negotiable Instruments Act, 1881. I therefore request you to receive this complaint, register an FIR, investigate the money trail, film-related inducement, utilisation/diversion of funds, agreement dated 24.01.2026, promissory notes, cheques, dishonour memos, Positive Pay evasion and threats, secure the relevant bank/electronic/film-related records, and take strict action against Mr. Gudluri Ashok Babu, Mrs Gudluri Vijayalaxmi and M/s A4 Motion Pictures in accordance with law.

Prayer

1. Receive this complaint and register FIR/criminal case in accordance with law.
2. Take immediate action against the accused for cheating, breach of trust, intimidation, conspiracy and allied offences;
3. Investigate the inducement through film/hero-launch promise, transfers of Rs.3,05,00,000/-, cheque of Rs.45,00,000/-, and admitted liability of about Rs.4,50,00,000/-;
5. Take such further action as is necessary in the interest of justice.
